Public Hearing:

Chairman Peck called to order the Public Hearing at 5:00 p.m. to consider the Petitions of Inclusion submitted by Colorado Mesa University, 330 Whitewater Hill Rd, Grand Junction, CO 81503 and Murray and Lisa Thiessen, 346 32 ½ Road, Palisade, CO 81526. The Notice of Public Hearing (07-15-21 File, Notices & Legal Ads, Daily Sentinel Legal Notices, Inclusions) was confirmed as published in the Grand Junction Daily Sentinel in accordance with C.R.S. 32-1-401. Manager Tooker reported that no comments have been received regarding the Petition of Inclusion from members of the public. No members of the public were present. Chairman Peck closed the Public Hearing at 5:03 p.m.

REGULAR MEETING

Chairman Peck called the August 5, 2021, Regular Meeting to order at 5:03 p.m.

MINUTES OF THE JULY 1, 2021, REGULAR MEETING

Director Slauson moved to approve the July 1, 2021, Regular Meeting Minutes. Director Diffendaffer seconded, and the motion passed unanimously.

MINUTES OF THE JULY 7, 2021, SPECIAL MEETING /STUDY SESSION

Director Slauson moved to approve the July 7, 2021, Special Meeting/Study Session Minutes. Director Diffendaffer seconded, and the motion passed unanimously.

MINUTES OF THE JULY 28, 2021, SPECIAL MEETING /STUDY SESSION

Director Slauson moved to approve the July 28, 2021, Special Meeting/Study Session Minutes. Director Diffendaffer seconded, and the motion passed unanimously.

FINANCIAL REPORT AND ACCOUNTS PAYABLE

Director Slauson moved to accept the Financial Report and Approve Accounts Payable Regular Checks of \$132,407.52, plus Supplemental Checks of \$46,930.72, plus Benefits Checks of

\$32,287.04, plus HRA Disbursements of \$3,605.47, for a total of \$215,230.75. Director Diffendaffer seconded, and the motion passed unanimously.

MANAGER'S REPORT

Manager Tooker reviewed the June 2021 Manager's Report (August-05-2021, File, Manager's Report).

INFORMATIONAL REPORT

Manager Tooker presented a video of the recent flashflood from the Pine Gulch burn area showing fire debris flowing down Kimball Creek to the Colorado River. The video clearly showed the amount of burn debris that significantly affected the water quality of the Colorado River. The resulting turbidity and fire debris was at historic levels never observed by District Staff. The Water Treatment Plant and Staff did an excellent job adjusting to the adverse conditions while maintaining production and water quality to District customers.

EXPRESS AGENDA

Director Diffendaffer made the motion to approve the Express Agenda items as presented. Director Slauson seconded, and the motion passed unanimously. The Express Agenda items are as follows:

SDA Annual Conference – The SDA Annual Conference will be held in Keystone, CO, September 14-16, 2021. Board Members interesting in attending contact Michelle Obadia for reservations and registration.

UNFINISHED BUSINESS

Drought Activity – Assistant Manager Reinertsen presented an Informational Report (08-05-2021 File, Staff Reports, Drought Response Plan 2021) summarizing the current Drought status. The Western Region of Colorado continues to be in D3- Extreme Drought and D4- Exceptional Drought conditions. The Federal Government is releasing water from Blue Mesa Reservoir and Flaming Gorge Reservoir to supplement Lake Powell water levels. The latest update from the Historic Users Pool (HUP) management group, indicates a reservoir release strategy that will maintain releases through October 2021, at a rate that meets the minimum water user needs. Staff prepared updated information reviewing possible watering restrictions, messaging, and conditions for implementing Emergency Water Rates. Due to the recent precipitation and extension of the HUP water until November, Staff recommended that no action be taken to implement Emergency Water Rates or watering restrictions at this time.

Staff will continue to work with Growl to tie local conditions to the messages they are sending out to the public as it relates to regional, basin-wide conditions.

Inclusion Request - Colorado Mesa University, 330 Whitewater Hill Road, Tax Parcel ID 2967-021-00-001 — The Board reviewed the Inclusion request by Colorado Mesa University. Director Mcelley moved to approve the Petition for Inclusion for the property identified as Tax Parcel # 2967-021-00-001, commonly known as 330 Whitewater Hill Road, Grand Junction, CO 81503 to be included within the District's boundary. Director Sparks seconded and the motion passed unanimously.

Director Mcelley moved to adopt the Resolution 2021-03 to Include Private Property (8/5/21 File, Resolutions, Inclusions). as submitted and authorize Staff to process the Certificate of Inclusion and all necessary paperwork for the District's legal counsel to complete the inclusion process with the District Court. Director Sparks seconded and the motion passed unanimously. The Resolution text is as follows:

Inclusion Request – Murray D. and Lisa G. Thiessen, 346 32 ½ Road, Tax ID Number 2943-234-00-069 – The Board reviewed the Inclusion request by Murray D. and Lisa G. Thiessen. Director Mcelley moved to approve the Petition for Inclusion for the property identified as Tax Parcel # 2943-234-00-069, commonly known as 346 32 ½ Road, Palisade, CO 81526 to be included within the District's boundary. Director Sparks seconded and the motion passed unanimously.

Director Mcelley moved to adopt the Resolution 2021-04 to Include Private Property (8/5/21File, Resolutions, Inclusions) as submitted and authorize Staff to process the Certificate of Inclusion and all necessary paperwork for the District's legal counsel to complete the inclusion process with the District Court. Director Sparks seconded and the motion passed unanimously. The Resolution text is as follows:

WHEREAS on June 7, 2021, Murray D and Lisa G. Thiessen, petitioned the Clifton Water District Board of Directors to include property within the boundaries of the Clifton Water District generally described as follows:

WHEREAS the District has previously included other Orchard Mesa properties into the District's the service boundaries.

NOW THEREFORE BE IT RESOLVED that the Clifton Water District Board of Directors approve the inclusion of the said property as described above, adopt the Order dated August 5, 2021, and authorize the Secretary and President of the Board to sign the Certificate of Inclusion and Order dated August 5, 2021.

Chairman Peck and Secretary Diffendaffer certified by signing the Certificate for Inclusion granted by Resolution 2021-04, Murray D. and Lisa G. Thiessen Parcel No. 2943-234-00-069 be included within the boundaries of the Clifton Water District and was unanimously adopted by the Board of Directors.

<u>Project 2020-01 AWIA Evaluation – Phase 2 Emergency Response Plan</u> – The District has initiated the second phase of the AWIA Evaluation with Black & Veatch Engineering to update the District's Emergency Response Plan. The completed Emergency Response Plan is due December 31, 2021, to the US EPA. Black & Veatch will make a presentation to The Board in October. No action taken, informational only.

<u>Manager Position</u> – The Board will be entering into a candidate search for the Manager's Position following Manager Tooker's retirement announcement. Advertisements will be made with an application deadline of September 1, 2021. Director Slauson moved to hold a Special Meeting/Study Session at 4:00 pm, Monday, August 23, 2021, to review the candidate search. Director Mcelley seconded, and the motion passed unanimously.

NEW BUSINESS

<u>Designate Person to Prepare 2022 District Budget</u> – By statute, the Board must appoint an individual to prepare the District's FY 2022 Budget. Director Sparks made a motion to appoint Manager Tooker to prepare the FY 2022 Budget. Director Diffendaffer seconded, and the motion passed unanimously.

<u>Manager's Evaluation</u> – September is the month for the Manager's review. No action taken, informational only.
