Finance Manager Isley explained that the process for a Special District to adopt an annual budget involves five different steps. One of those steps, in accordance with $\S29-1-106(1)$, C.R.S., is publishing a notice of the date and time of the budget hearing, along with a notification that the budget is open for public inspection, and the location where the budget may be reviewed. This notice is also to include a statement that interested parties may file objections any time prior to final adoption. Manager Jones added that this step had not been taken prior to the December 14th meeting and this Special Meeting was called with the purpose of correcting the oversight.
